ABOUT THE TEST FEST PERCENTAGE DAYS

- We wish to acknowledge the land on which the VDRC operates is the unceded territory of the Sylix (Okanagan) Peoples.
- The practice day is not a competition. It's a chance to get out in an encouraging "show" atmosphere and have an opportunity to further your dressage skills. Everyone is welcome.
- The objective is to raise your percentages after the judge's feedback. You may opt to re-ride the same test or another test (to a maximum of 4 rides per equine-rider combo.).
- Each scheduled test allows for the test riding, plus additional time to for live feedback from the judge.
- Feedback may be videoed/recorded from **outside the field of play** (outside of the sand area) by a person appointed by the rider.
- Tests will be scored if we have volunteers to do so. We are happy to show you how to calculate your test.
- Percentage days are run by volunteers. Without their dedication the percentage days would not be possible. Please consider lending a hand. Wish to learn how to scribe or score? Just let us know.
- **CLOSING DATE: MONDAY JULY 3.**

To avoid disappointment, have your entry in early!

Waiting lists will be in priority of entry received.

Entries must be complete with all accompanying information (See check list). Email will be sent confirming entry. Incomplete or entries without confirmed/cleared payment will NOT be processed!

RIDE TIMES: Posted to facebook VDRC page the evening of Wednesday before the percent day.

Times will be emailed to the email on the entry. Please make sure it is legible 😊

General Information/Rules/Tips:

<p>WARM UP ETIQUETTE</p>	<ul style="list-style-type: none"> • No warming up in the jumper ring. • Please do not block the entrance to the warm-up. • If you need to adjust tack, etc. please do so outside of the warm-up area. • Pass left to left. • Slower moving riders (e.g. walking) please stay to the inside of the ring. Cantering riders and trotting riders to have the track. • As a courtesy, please let a rider know when you are passing them and provide as much space as possible. • If your equine is prone to kicking, please put a RED ribbon in the tail. Riders please be aware. • If riding a stallion please put a BLUE ribbon in the tail. • Using a headset – please only wear one ear bud so you are aware of what is going on around you. • Please keep in mind clucking, or voice cues across the warm up ring may be disruptive to other equines. Best to stay ringside and cue the rider as they pass you. • Going to serpentine, zig zag or perhaps circle in an unusual spot? Call out your intentions to make everyone aware. • Not all equines may have seen strollers, umbrellas, or like humans in rain ponchos or be fond of dogs ringside. Always approach the warmup area with caution. • The warm-up ring is intended for those about to enter their class(es) and priority will be given to these riders should the warmup ring have more than 6 equines.
<p>PETS</p>	<p>Dogs and other pets are discouraged. If you <u>must</u> bring your pet, it must be well behaved and under your direct control on a leash, at all times.</p>
<p>SMOKING</p>	<p>Smoking/vaping is not allowed on VDRC grounds – this includes in any of the buildings, including stabling, show office or in competition and warm-up areas.</p>
<p>SCHOOLING <i>in show ring</i> LUNGING</p>	<ul style="list-style-type: none"> • SHOW RINGS ARE CLOSED FROM FRIDAY 3 PM ONWARD SO THEY MAY BE PREPARED FOR THE SHOW. • Lungeing (unmounted) is permitted in designated outdoor lungeing area only. • Under no circumstances shall lungeing be permitted in warm-up/show areas.
<p>NON- COMPETING EQUINES</p>	<ul style="list-style-type: none"> • The non-competing equine (NCE) is subject to all the show rules as competing equines (an Entry form must be submitted). • There will not be any entry or office fees. • NCE must provide proof of vaccinations, and HCBC coverage and liability coverage (in the event of a riding/commercial stable) . • Stabling for a NCE will only be approved after all competing equines are accommodated.



INSURANCE	All owners or competitors are personally responsible for damages to third parties caused by themselves, their employees, their agents, trainers, or their equines.
HEADGEAR	All riders must wear properly fitted and fastened safety-approved headgear when mounted.
Emergency plan/evacuation	<ul style="list-style-type: none"> • In the event of an emergency <u>the show office</u> will contact 911. • Please follow directions of the volunteers (dismount and make way for emergency vehicles). • In the event of an evacuation, please follow the direction of the announcer and volunteers.
Food/Canteen	<ul style="list-style-type: none"> • We will NOT have a canteen. Please pack snacks and drinks.

DRY STALL	<ul style="list-style-type: none"> • Day use of dry stall is complimentary but must be left clean
RIDE TIMES SCHEDULE	If you wish to ride your tests immediately one after another (back-to back) please indicate on the show form. We will try to accommodate ride time requests whenever possible. NOTE: 20 x 40 ring size tests will be scheduled at the end.
ATTIRE TURNOUT	<ul style="list-style-type: none"> ➤ Rider and equine should be neatly presented. ➤ Brushing boots and bandages may be worn. ➤ Tie downs, martingales are not permitted. ➤ Bits/general tack rules will mirror those of the governing body – e.g. Equestrian Canada, Pony Club, Working Equitation, etc.
TEST CALLERS	<ul style="list-style-type: none"> ➤ Permitted for ALL tests including FEI ➤ Should be neatly attired. ➤ To stand behind B or E. ➤ May call a movement at maximum twice. NO additional comments/coaching.
FREESTYLES	Please contact the show secretary as for how you're best to submit your music.

no changes of tests will NOT be permitted once ride times are sent out. The reasons for this are the tests are printed and organized by one of our volunteers days in advance. Our judges equally want time to review the tests they are to judge and we schedule wherever possible tests by level.

VACCINATIONS	<p>All equines attending VDRC Test Fest Days or events must provide proof of Equine Influenza and Equine Herpes Virus (1 and 4) vaccinations within six (6) months (+21 days grace period) before arrival at VDRC. No equine shall have received vaccination within seven (7) days prior to arrival.</p> <p>Proof of vaccination MUST be provided with entry (copy of vet receipt showing equines' name and date of administration) or vaccination certificate or FEI vaccine passport page.</p>
2023 HCBC membership	Proof of Horse Council of British Columbia's membership for 2023 is required to be submitted with the entry for both equine owner and rider.
Commercial coverage for third party liability	In cases where the equine is leased (monies exchanged) or used in a riding school or person is being paid to ride the equine, then proof of third-party liability coverage specifically for attending equine clinics and competitions must be provided.

 - (a) the propensity of any equine to behave in ways that may result in injury, harm or death to persons on or around them and to potentially collide with, bite or kick other animals, people or objects;
 - (b) the unpredictability of an equine's reaction to such things as sounds, sudden movement, tremors, vibrations, unfamiliar objects, persons or other animals and hazards such as subsurface objects;
 - (c) the potential for other participants to behave in a negligent manner that may contribute to injury to themselves or others, including failing to act within their abilities to maintain control over an equine.
